#### Prioritize Seamless Integration and User Experience

Fragmentation across multiple tools and poor user experience are major pain points. Schools should focus on adopting tools that integrate well with existing systems, offer intuitive interfaces, and minimize the learning curve for staff. Conducting thorough usability testing before implementation can help address these issues.

# Ensure Compliance with Local Regulations and Data Privacy Laws

Given the emphasis on data privacy, security, and compliance (especially in regions like China), decision makers must ensure tools meet legal requirements and align with internal policies. Regular audits, third-party checks, and staff training on data protection are essential to maintaining trust and security.

### Balanced Budget, Practicality, and Long-Term Goals

While budget constraints are a reality, schools should avoid short-sighted decisions. Tools should not only fit current needs but also support long-term strategic goals. Involving diverse stakeholders in the decision-making process can help strike the right balance between cost, functionality, and usability.
