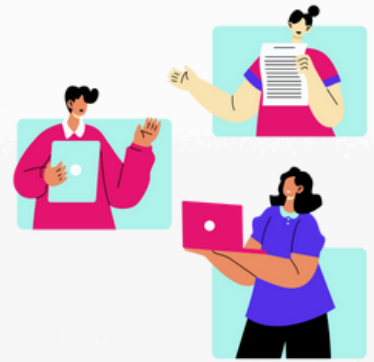

## Crisis Response Protocol

Hosts presented the context for CRP and a range of protocols, roles and responsibilities for various Safeguarding Team members tailored for the International School setting. Different templates for meetings and care plans were shared with the group before diving into discussions of case studies with examples provided by participants.

## Discussions about customizing

Crisis Response Protocols: Participants discussed applications of the protocol in their settings keeping in mind unique nuances of the cultural and geo-political context. Break outs rooms provided the opportunity to embed the learning from the presentation.

## Q&A and Next Steps

Participants continued discussions about their experiences in Crisis Response situations and best practices. Hosts invited suggestions for focus areas for upcoming live sessions. Difficult Conversations with families and Online Safety emerged as the two main areas the group would like to focus on.

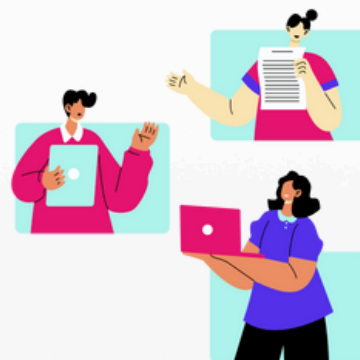

## Proactive Online Safety Awareness

The session underscored the importance of identifying trends in digital risks and establishing clear safeguarding measures. Educators examined patterns of online harm and discussed how consistent policies and parental education can mitigate risks. This proactive approach aims to protect students by addressing both in-school and home environments.

## Collaborative Problem-Solving in Safeguarding

Participants engaged in small group discussions to share real-life scenarios and challenges related to online safety. They collaboratively explored solutions—from improving digital citizenship and setting boundaries on device usage to implementing family tech agreements—highlighting the critical role of teamwork among educators, parents, and staff in preventing online harm.

## Reflective Action for Enhanced Child Protection

The session concluded with reflective exercises that prompted educators to identify one actionable step to improve online safeguarding. This reflection focused on immediate actions such as resource sharing, targeted parent training, and continuous policy refinement—ensuring that the school's approach to child protection evolves alongside emerging digital challenges.

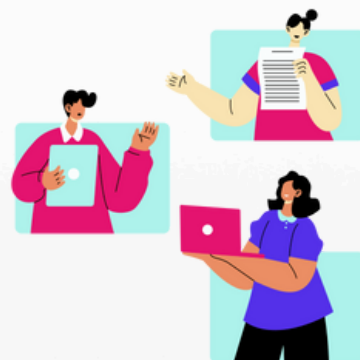

## Understanding Affluent Neglect

Affluent neglect refers to emotional neglect in wealthy families, where material abundance does not compensate for a lack of emotional connection or supervision. It is often difficult to identify because it doesn't involve physical signs of neglect. This form of neglect can lead to psychological issues such as anxiety and depression in children. Schools need to develop strategies to recognize and address this issue effectively.

## Safeguarding Challenges in High-Status Families

In high-status families, emotional neglect is often overlooked because the child appears well-cared-for on the outside. These children may struggle with perfectionism, isolation, and low self-esteem, despite academic success. The challenge for schools is recognizing these subtle issues that don't show in traditional safeguarding signs. Safeguarding in these cases requires sensitive awareness and careful observation.

## Practical Approaches for Schools

Schools can support students from affluent families by creating environments that address both emotional and academic needs. Engaging families in open, respectful dialogue is crucial, as is being proactive about identifying emotional struggles. Encouraging collaboration between educators and parents helps ensure that children receive the support they need. Sensitivity and confidentiality are key to navigating these conversations.
